

DF Concerts TRNSMT Festival Promotion

Summary Terms and Conditions

Promotion runs from 16:00 to 17:00 26/11/19 inclusive. Applicants must be 12 years or over and resident in the UK. No purchase necessary. T&Cs apply. To enter, simply follow the clues to search for the artists we're revealing on our 'TRNSMT Marks The Spot' website and share your discovery on Twitter or Facebook using the button provided. Facebook entries must be posted as a comment within the pinned post on our page. For each artist reveal, entries will be limited to a maximum two entries per person (one per social channel – Facebook and Twitter). Winners will be selected randomly by DF Concerts ("Promoter"). One prize per person, prizes are not transferable. Competition closes at 5pm on 26/11/19, with all winners chosen at random and notified by no later than 8pm on 26/11/19. Prizes available: 1 of 36 pairs of weekend tickets to TRNSMT.

Full Terms and Conditions

By entering this promotion, individuals will be deemed to have read and understood these Terms and Conditions and shall be bound by them.
